Our efforts to register voters was strong and our outreach about the LWV mission flourished. We welcomed many new members and diligently met once a month to iron out program, policy, and event planning.

In June, I enjoyed attending the League of Women Voters of Pennsylvania Biennial Convention in June with members Mary Grill and Tressa Monkman (photo). Tressa was elected Treasurer for the LWVPA Board of Directors. At this convention delegates, chosen from each local League ahead of time, voted using Parliamentary Procedures and Robert's Rules of Order that involved debate, discussion, and clarification. If there was a dissent, there was a vote. Some might find this a tedious process but I was immediately captivated by the intelligence and thoughtfulness of each contribution.



This Fall, our local League attempted to host several candidate forums, we wrote Letters to the Editor to clarify the importance of friendly debates, and we created and shared a tutorial video that explained to voters how to properly complete mail in ballots in the general election. Again, members attended the Board of Elections meeting and we made statements concerning the fourth consecutive error on mail-in ballots for our voters. We will continue to be informed and present to hold elected officials accountable.

In closing, I hope you are as excited about our future in Lancaster County as civic engagement motivators as I am. Our 2024 Plan & Path will be strategic, focused, and full of potential. Stay tuned for details about our partnerships and projects as we continually seek to enlarge our general membership, volunteer pool, and committee level workers all while using the LWVUS and LWVPA resources to guide us.

### Kenderdine Lectures by Amy Fasano

#### Harriet Webb Kenderdine (1899 - 1982)

Harriet was an active member of the League of Women Voters at the local, state, *and* national levels and she had a deep interest in international affairs, serving as the Chair of the LWVUS Study on the United Nations in 1965. When Mrs. Kenderdine died in September 1982, she left a bequest to the local league. She set aside funds for lecturers for public events on behalf of the LWV, underwriting the costs as long as the speaker was representative of their ideals, which include educating voters and promoting the advancement of civil rights.

In September, talks resumed with Millersville University faculty and executives to revive the Kenderdine Lectures. A new committee was formed and the efforts will be maintained by the Center for Civic Responsibility and Leadership; including the help of our LWV member, Jill Craven. In the past, lecturers have included human and civil rights leaders and authors, leading congressional and legal affairs correspondents, and United Nations representatives. I am excited to foster this collaboration, engage with new partners and launch our next lecture in the Fall, 2024!

# **CANDIDATE FORUMS...** ~ by Carolyn Hernandez

Invitations to participate in candidate forums, otherwise known as debates, were sent to the Warwick and Elizabethtown School Boards and the Magisterial District Judge candidates (In partnership with the Bail Reform Coalition) in September. In accordance with our No Empty Chair policy, we were not able to hold the debates due to lack of participation from some candidates. Carolyn Hernandez, Vice Chairperson, wrote a Letter to the Editor at LNP on October 2<sup>nd</sup>, stressing the importance of candidate participation in these types of election activities so increase transparency and voter trust.

On October 11th, in collaboration with the Center for Civic Responsibility and Leadership at Millersville University, the LWVLC sent invitations to the four candidates on the ballot for judge on the Court of Common Pleas. The RSVP for the event was October 20th. Due to a lack of response, the forum could not be held.

The LWVLC looks forward to working with the Center for Civic Responsibility and Leadership at Millersville University, F&M's Ware Institute for Civic Engagement, and other nonpartisan partners on future forums on the importance of democracy and hopefully, candidate debates. The LWVLC remains committed to helping voters get to know their candidates, and will gladly work with candidates interested in participating in forums. We are transparent in our work to host professional debates with experienced moderators, identifying a diverse group of questioners and crafting job function specific questions for the candidates.

## Conservation District Follow Up by Jenny Engle

The League is a nominating organization for the board of the Lancaster County Conservation District. Last year our League nominated me for a board seat. I completed an application, which then went to the County Commissioners, who voted to approve my nomination. I became an associate board member and have been learning about all the things the staff of the LCCD do on their own, in partnership with other conservation districts, and with the state and federal governments. In addition, I attend monthly board meetings, serve on the marketing and communications committee, help with strategic planning, and attend reciprocal training and social events as I am able. This has been a terrific learning opportunity and I hope League members will consider volunteering with some of the LCCD's future conservation projects.
